- 10. - 11. - 13. The optimum Section teacher ratio of 1:1.5 as well as student teacher ratio of 30:1 is to be maintained to teach various subjects and school shall appoint qualified and trained teaching staff on regular basis as per provisions of Affiliation Bye Laws of the Board.
- 14. Every affiliated school shall sponsor regularly its bonafide and eligible students in Boards Class X and Class XII examinations from the year mentioned while granting affiliation/upgradation regularly without break or inform with reasons thereof in writing well in time about the non-sponsoring of the candidates.
- 15. Running of coaching institutions in the school premises in the pretext of providing coaching to the students for various examinations is not permitted by the Board. Strict action would be taken on defaulters.
- 16. The Manager and the Principal of the school shall be jointly responsible for the authenticity of the online/offline documents/ information/data submitted by the School to the Board.
- 17. This is with reference to your online application No. EX-00450-1415 executed on 02/05/2013, on the above subject. In this connection, I am directed to convey the sanction for regularization of extension of provisional affiliation of the school with the Board for its Secondary School Examination and Senior School Certificate Examination for a further period of Five years w.e.f. 01.04.2014 to 31.03.2019 subject to the fulfillment of the following conditions:-

1. The School is required to follow syllabi and course as per scheme of studies prescribed by the Board for the respective Examination.

2. The School is required to abide itself by the Examination/Affiliation-Bye-Laws of the Board.

3. The School is required to apply on online for further extension of affiliation alongwith the requisite fee and other documents by 30th June of the preceding year in which the Provisional Affiliation expires. Applications will be accepted after the last date along with the prescribed fee and late fee ₹ 10,000 per month subject to Maximum of ₹ 50,000/-.

The school will strictly adhere with all rules regarding safety of students including Fire fighting, Drinking water, Sanitation, Transportation, etc.

Income & Expenditure and audited annual accounts statement duly certified by the Chartered Accountant for the current year is required to be sent and the same be submitted every year.

7. Other conditions are enclosed as per Annexure 'A'.

8. Special conditions to be complied within three months:-

a) Present School Managing Committee is required to be reconstituted as the same has not been constituted as per Affiliation Bye-laws. Therefore, it may be reconstituted by including representatives of 02 teachers, 02 parents, 02 CBSE nominees and also ensure that no blood relation is in it.

b) School is required either to pay salary i.e. Basic pay, DA and other admissible allowances at par with the State Govt. teachers or VIth pay commission. An evidence to this effect, a copy of acquittance roll for the last 03

months along-with Banker Certificate are required to be submitted in support of it.

c) In few classes the school is having a large enrolment making the class over crowded. As per Affiliation Byelaws of the Board the optimum strength of a section should not exceed more than 40 students. The school is required to submit a list of enrolment of students class/section wise.

d) The school is required to maintain the reserve funds in the joint names of Secretary, CBSE and Manager of the school as per provisions of Affiliation/Bye-Laws of the Board and photocopy of the same is required.

e) The school is required to submit copy of challan through which amount of EPF has been deposited in the appearance Department.

5. The school has as many as 03 untrained teachers whereas only trained and qualified teachers are required to be appointed by the school.

6. The school is required to maintain optimum strength of 40 students per section in each class as the enrollment in each section upto class- XII is high.

- Running /Starting of class IX/X or XI/XII without prior Provisional Affiliation upto Secondary level /Sr. Secondary level from the Board would be unauthorised and school shall be responsible for the consequences arising out of it.
- Non submission of application for extension of Provisional Affiliation by 30th June of the year preceding to the
  year by which provisional affiliation granted, expires, would also attract violation of provisions of Affiliation

- 4. - The School shall maintain Section teacher Ratio at least 1:1:5 at each level i.e. primary (I-V) Secondary (VI-X) and Sr. secondary (XI-XII)

- 19. Annual fee @ Rs.1000/- per annum for the year(s) 01.04.2006 to 31.03.2009 (03 yrs.) be also remitted at an early date. (In case of overseas Independent school @ Rs. 5000/- p.a. and overseas Kendriya Vidyalayas @ Rs. 3500/- p.a.)
- 20. The school will apply for further Extension of Provisional Affiliation on the prescribed form together with the prescribed fee and other essential documents in the preceding year before the expiry of the date.
- 21. Renewal of Registration of Society be ensured.
- 22. The school is also advised to implement Rule 11, Sub.
